Background

Many customers choose "re-implementation" when moving from Dynamics NAV to Dynamics 365 Business Central. This involves starting with a new installation of Business Central, preferably copying over some basic data, but otherwise dropping historical data.

In such a situation, it often becomes a question of up-preservation of historical accounting data as well as the possibility of general lookups in historical data.

Solution

Oseberg can offer a "NAV archive" that satisfies public requirements for the storage of accounting data and allows you to look up the old solution at a reasonable price.

We install your old Dynamics NAV solution on our servers and give you as a customer access to the system via Azure Virtual Desktop. You log in as you always have on your old system with full access to historical data.

Storage requirements and how the storage obligation is fulfilled

There is a general requirement for the retention of accounting data for 5 years. Details of this can be found here:

Storage requirements and how the storage obligation is fulfilled

Accounting documents	5 years	NAV-Archive	Documents that are handled by electronic document management. Other documents must be kept by the company liable for accounting.
Specifications	5 years	NAV-Archive	Account, customer and vendor specifications
Documentation of the balance sheet	5 years	The company liable for accounting	Electronic or paper
Annual Accounting	5 years	The company liable for accounting	Electronic or paper
Annual Report	5 years	The company liable for accounting	Electronic or paper
Audit Report	5 years	The company liable for accounting	Electronic or paper
Numbered letter from the auditor	5 years	The company liable for accounting	Electronic or paper
Agreements of importance	3.5 years	The company liable for accounting	Electronic or paper
Important additional information	3.5 years	The company liable for accounting	Letters and other things. Electronic or paper.
Outgoing packing- and order slips	3.5 years	NAV-Archive	Attachments that are handled by Dynamics NAV. Other documents must be kept by the company liable for accounting.
Price lists	3.5 years	The company liable for accounting	When required by law or regulation. Electronic or paper.
Personnel list	3.5 years	The company liable for accounting	When required (e.g. hairdressers, catering establishments). Electronic or paper.

In the case of electronic storage, there is a requirement for a backup copy in the event of data loss. Oseberg's NAV archive is backed up.

The solution will be offered as a base with one user (can be expanded if necessary).
